In 1990 the Government decided that some of the mistakes of the 1974 Local Government Re-organisation should be corrected. The Local Government Commission was set up to address the problem. At the time it seemed that artificial authorities such as Avon. Cleveland and Humberside at County level, and some district councils, were the target; with an indication that any new authorities created, could be either unitary authorities or two tier depending on local circumstances. This was interpreted as meaning that the large towns and cities, which prior to 1974 enjoyed County Borough status, would have their autonomy returned. (NB a County Borough was the equivalent of what is now described as a unitary authority, responsible for all local government services within its area). The areas outside these large towns and cities would continue with the two tier system of County and District Councils.

Apparently the goal posts have been moved and it would appear that Unitary Authorities are expected to be the norm although, it is said, that where communities are agreed the present two tier structure can continue. To date the government has rejected all recommendations by the Local Government Commission proposing to retain a two tier system of local government.

By accident or design Hertfordshire is amongst the last areas to be considered, and the various parts of local government in the county have until 31 May to put forward their proposals. It is thought that if the various authorities can agree a formula for Hertfordshire then this would have a very good chance of being accepted by the Local Government Commission.

Including the County Council there are 11 local authorities for Hertfordshire and at the moment 14 possible structures are being considered. These range from, at the top, a single unitary authority to cover the whole county, through various combinations of district councils, and parts of district councils, to form smaller unitary authorities, all the way down to 10 unitary authorities based on the existing district councils to finally maintaining the status quo of a two tier system.

What is a Unitary Authority and why is it such a paragon of virtue?

A unitary authority is a local authority which is deemed to have sufficient resources to provide all the local government services for the citizens of its area and is claimed to eliminate the confusion that is alleged to exist among the public as to the respective duties of

county and district councils. That is the theory but in practice some functions, eg Police and Fire Brigade, will continue on a county wide basis albeit under the auspices of joint committees. There are arguments for other services to follow this road and then there are the undercover services - Archives for example, their value is in a county wide base and one can see them disappearing, there being no peg on which to hang them in the new "unnatural" authorities.

The draft policy guidance to the Local Government Commission made in September 1993 argues that "unitary Authorities can reduce bureaucracy and costs and improve co-ordination and quality of services". It then goes on to say that the commission should see whether a unitary authority better reflects the identities and interests of local communities and secure convenient and effective local government. In considering its recommendations the Commission are required to weigh the costs of change, including transitional costs against the benefits of its proposals. The Commission should also take account of people's expressed preferences. (even though the government will probably ignore them - see previous comment).

### Whither Three Rivers and Croxley Green?

For South West Hertfordshire there are a number of permutations, of which the principal ones are:-

- a) Three Rivers, Dacorum, Watford (289,335 pop)
- b) Three Rivers, Hertsmere, Watford (245,805 pop)
- c) Three Rivers, Watford

(155,419 pop)

d) Three Rivers, Dacorum

(213,562 pop)

- e) Three Rivers as a unitary authority (79,646 pop)
- f) Three Rivers remaining as a district council within a two tier structure.

In addition there are a number of combinations involving individual parishes.

Within the Parish Council the consensus is to support the merging of Three Rivers and Dacorum primarily in the belief that this would produce a more sympathetic appreciation of the various parish councils. Even so there are minority views for merging with Watford and for the status quo, a view which may be strengthening.

So far to date you the ordinary citizen have not been asked to express an opinion on how and where your local government services should be administered.

as soon as possible and certainly before 31 May 1994.

#### Conclusion

It is anticipated that the Commission will take some 9 weeks to digest the various opinions placed before it and will reach preliminary conclusions by early August.

As the Parish Council understands the procedure the Commission will advise all households of its proposals, but will probably not justify them, and you will be asked to express an opinion. It is on the basis of these responses that the Commission will formulate its definitive recommendation for submission to the government. The Parish Council would urge you all to respond to the Commissions request accepting, as you have probably noticed, that this important paperwork will be arriving during the peak holiday period. Draw your own conclusions!

#### Parish Councils

Although Parish Councils, and their more recent counterparts Town and Community Councils, are not formally involved in the reorganisation their presence is recognised. They will continue in the new format, whatever that may be, and those areas not currently parished will be urged to form Parish Councils as appropriate. As far as is known there is no intention by the government of legislating to increase the powers of Parish Councils. Your Parish Council, in conjunction with the Parish Councils within Three Rivers and beyond, supports the call for Parish Councils to be granted the option of taking responsibility for local functions. In the absence of legislation it will be necessary to persuade the appropriate senior authority to trust the Parish and implement the various options which are available.

Such is the future of your local (!) government. Your opinion is important and you are earnestly urged to exercise your democratic right to express by writing to one or all the addresses mentioned above. Failing that write or call in at the Parish Office.

## STONE'S ORCHARD Off The Green

Old orchards are disappearing at an alarming rate and Hertfordshire, in particular, has very few remaining.

Stone's Orchard was once such an orchard, well known in Croxley Green for its cherries, but apples, pears, plums and cob nuts were also grown. Walter Stone, from whom the name derives, became a tenant farmer in 1893. Previously known as Shepherd's Farm, the owner Walter Stone and his family lived at Rose Cottage and kept horses, cows and pigs that roamed the orchard freely. Families walked to the Green, during the cherry picking season, to buy and eat their cherries. Many wealthy families sent boxes to as far away as Devon and Scotland.

The Environment Committee has met with representatives of the Hertfordshire Environmental Records Centre and the Countryside Management Services to discuss the future of Stone's Orchard. During late April / early May a full survey of the orchard will be carried out by the HERC, so that a draft Management Plan can be compiled for discussion.

Concern, however at the moment, is centred around the ragwort which is taking over. The HERC has recommended that *Ragwort pulling* weekends are organised to control the plant. These are organised for Sunday 15 May and July 3, both from 10.00am.

#### COMMUNITY BUS SERVICE

Commencing on Friday 8 April 1994 the Council is introducing what it believes is an improved service. The object of the exercise is to provide, as near as possible, a door-to-door service for Senior Citizens and persons resident in sheltered accommodation, proof of eligibility may be required.

The time table (left) indicates the various pick-up points but if potential passengers have other suggestions, please let the Clerk know. Whilst the Council cannot guarantee to include all suggestions, every effort will be made to be accommodating where practical. The service operates every Friday except Good Friday (runs Thursday) and at Christmas, when a suitable day will be selected as the holiday period dictates.

### COMMON MOOR LOCK.

During the summer of 1993, committee members walked the Common Moor Lock area, as we were most unhappy at the way in which the whole area was becoming neglected. After wide and varied discussions, that took place at the Environment & Amenity Committee's meeting on 5th October, it was proposed that a combined report, and photographs taken by Clir Waldron, should be submitted to the Environmental Forum on October 19th 1993 at Three Rivers House, Cllr Pomfret duly brought these concerns to that meeting and again on February 22nd 1994, with up-to-date photographs of the growing devastation of this area.


We are encouraged to see that TRDC have initiated the removal of abandoned vehicles and the whole area is now under a proposed clean-up and management scheme, so that the residents of the parish can enjoy this valuable corner of Croxley Green. Another Parish Council initiative now taken up by others. We have also recommended that the growing rubble barrier to the Long Valley Wood area is addressed, as this too is becoming an area for opportunists to target their unwanted debris.



### **PUBLIC TRANSPORT**

In response to a request from TRDC for suggestions to improve local bus services, the Parish Council has made two proposals:-

- a) Restoration of the local Shopper Bus (Route W21) between Croxley Green and Watford.
- b) That routes W4 and 344 be redirected via Watford General Hospital to provide a regular direct service for residents of North Croxley.



#### DOG HYGIENE

Many pet owners will be aware that there are going to be new bye-laws introduced whereby, should a dog foul anywhere in public and the faeces are not picked up, the owner can be fined very heavily. To help with this and assist all dog-owners, we are hoping to install many more waste bins throughout the parish. At present there are 8 in use and shortly more will be introduced. The committee will then recommend more sites, so that residents can easily remove any faeces to avoid being fined.

The map shows the 8 sites where bins are already installed. The proposed new sites are: Footpath adjacent to Malvern Way School/Winton Crescent, Stone's Orchard, Owens Way/Green footpath and Common Moor Lock.

It makes sense to clean up!

# AFTER SCHOOL CHILD CARE SCHEME

Those of you with young children, who were hoping to use After School Child Care, must be thoroughly disillusioned with the Council. Needless to say the Council is itself embarrassed that the high hopes of 12-18 months ago have not yet been fulfilled.

The reason for the delay has been the lack of suitable accommodation either, because premises were not available for the times required due to existing commitments or deemed not suitable.

The Council has not given up the idea and various accommodation opportunities are being explored as they become known and subject to resources available to the Council. As soon as there is definite information you will be informed, especially those parents who have already registered an interest.

### ENVIRONMENT DAY WATERSMEET - MARCH 12.

The Environment Committee agreed to participate, for the first time, in the annual Environmental Day at Watersmeet, the theme for the day being all aspects of *Water*.

We decided to display the Parish Map and with that a photographic display of past and present aspects of water relating to Croxley Green. We are very fortunate that the Parish contains the Rivers Chess and Gade with the Canal.

Clirs Herbert, Waldron and Pomfret were present to represent the committee. Photographs and materials, featuring these waterways and others, were on display including the Croxley House Well-head, waterpipes across the Green and pollution of the Gade / canal in the 1890s and 1949.

### CROXLEY RAIL LINK

Most readers will know that London Underground Ltd have decided upon the Northern alignment for re-directing the Metropolitan Line to join the BR Line at Croxley Green branch for a through service to Watford Junction. It is proposed that the Link will leave the existing line east of the Baldwins Lane bridge, cross Cinnamond's site and Watford Road (A412) to rejoin the existing BR embankment by way of a new bridge across the Canal and the River Gade.

The Parish Council has consistently supported the principle of the Rail Link whilst at the same time arguing for a sensible and acceptable route. The Council believes that the route now proposed is the best of the several alternatives considered, although concern has been expressed as to the well being of the occupiers of the canalside cottages.

One of the alternative routes which was considered was a proposal to use part of the old Watford - Rickmansworth line across Common Moor. The Council opposed this proposal, not only because it was considered environmentally unsuitable but also, because it would take the railway to the southern boundary of the Parish , away from the bulk of the local residents leading to the eventual closure of Croxley Station. It is understood that the *Environmental Assessment* of this route also comes out against the proposal, though the report has not yet been made available.

In conjunction with the Croxley Rail Link, Hertfordshire County Council are promoting the Ascot Road Improvement Scheme. This will provide a dual carriageway from the roundabout outside the Sun Printers building and running parallel to, and to the east of, the existing Ascot Road to the junction with Hatters Lane and Greenhill Crescent serving both the Watford and Croxley Business Parks.

It is anticipated that LUL would build a new station, preferably to the west of the Ascot Road bridge and that the old Sun Printers car park would provide commuter parking for 200 cars. Access to the proposed station for buses and taxis would be by way of a service road linking the new and old Ascot Roads. That area of the present Ascot Road, outside the Sun Printers, would be sealed off at its junction with Whippendell Road to become a cul-de-sac. It is obvious that, if and when, both or either of these schemes gets off the ground, there could be serious traffic problems for all road users negotiating the Watford Rd / Rickmansworth Rd / Whippendell Rd junction complex including the emergency services.

The Parish Council is represented on the Local Authorities Joint Committee, alongside Three Rivers District Council, which is overseeing the Rail Link Project. The road scheme comes naturally into the discussions. With this involvement the Council can, and will, be arguing for the mitigation of the traffic problems during the construction of the two schemes and proposing various solutions. The Council is also looking ahead to the finished Rail Link and will be trying to ensure that the Link is clothed to blend in with the local topography, as quickly as possible.

To date the Council has submitted, or is about to submit, the following requirements:-

- a) That consideration be given to using the Canal for the import / export of materials and waste and for the maximum use of rail traffic.
- b) All containers to be adequately sheeted.
- Engineering design to seek to eliminate wheel squeal as far as is practical.
- d) Any new embankment to be clothed in semi-mature trees and shrubs with a policy of replacement of failures in the early years.
- e) LUL are to be asked to avoid using the Children's playground.
- f) A joint investigation, involving TRDC, to explore the feasibility of a footpath to the proposed Ascot Road station, using the future dead spur from Croxley Green station.
- g) That any spoil created by breaching the BR embankment for the Ascot Road Improvement Scheme be retained for use in any new LUL embankments.
- h) That the existing BR service be suspended only between Watford West and Croxley Green whilst the various works are carried out.
- That a lorry cleansing station be set up.

NB These comments may apply to either or both schemes.

Naturally, as other problems arise, the Council will be monitoring the situation and proposing possible solutions, if necessary. The real work concerning the Croxley Rail Link is only now beginning. London Underground anticipate that they will hold informal consultations in the Summer, when drawings will be available, rather similar to the exercise which happened in the latter part of last year. At some later time it is anticipated that a formal consultation exercise will be carried out,

when models will be displayed and various perspective views shown. Look out for further information in the local press. In due course it is anticipated that there will be a Public Enquiry.

This is the present position of the Croxley Rail Link proposals. The Council believes that the development will be good for Croxley Green and will not only provide local residents with a good service to Watford but also offer a service to other travellers to-and-from Watford instead of using the car. In due course there is the possibility of a rail link to Rickmansworth and, further into the future, even beyond including possibly London Airport.

Hopefully you will have found this brief discourse both interesting and informative. # BEST KEPT VILLAGE COMPETITION

Last summer, for the first time, the Parish Council joined in this event which is organised by the Hertfordshire Conservation Society. We tested the waters to see how we compared with those villages who have a more rural setting and have been entering for many years.

The following are extracts from the judges' remarks:-

- a) An almost complete absence of litter on the Green and none spotted elsewhere.
- b) Roads and footpaths well maintained, verges recently mown and hedges trimmed, walls, fences and trees in good shape everywhere.
- Green looking splendid and Stone's Orchard most impressive wild life oasis. Allotments appeared well cultivated.
- d) There appeared to be a high level of communal care and interest in the village, houses throughout appear well maintained with attractively planted and carefully tended gardens.

Marks out of 100 by two judges were 88 and 83.

The judging took place on 23/24 June 1993. We hope to enter again this year. Well done Croxley Green.

#### **BALDWINS LANE SURGERY**

Residents, particularly those in the north-west corner of the parish, will be aware that Drs Miller and Flude, currently in practice at 268 Baldwins Lane, have sought planning approval to transfer the practice to premises in New Road

The Parish Council was not happy with this proposal believing, as many residents have since demonstrated, that the practice should, if at all possible, be retained in the vicinity of its present premises. The council accepted that in planning terms the only real grounds for objection to the New Road proposal would be lack of parking facilities and traffic congestion. At its meeting of 24 March 1994 the Planning Committee of TRDC, after a site visit, agreed to refuse the application for these and other reasons.

It is probably fair comment that many people were aware that this particular practice had outgrown its existing premises and yet it needed an unsatisfactory planning application for this problem to be properly identified. Surely there is a lesson to be learnt here!

As the Parish Council was unhappy with the proposals for New Road, and bearing in mind the importance and necessity of this service to local residents, it was felt incumbent on the Council to assist in identifying alternative sites and/or premises. A meeting was held with one of the Doctors, a representative of the Family Practitioners Committee, a local District Councillor and a few Parish Councillors to try to find a solution. It is not easy, but some initiatives have been started and hopefully will bear fruit.

Whatever the outcome of this problem it is hoped that the result will be one that, whilst being satisfactory for the practice, will also be beneficial and satisfactory to the patients.
